Mr. _____,

Praised be Jesus, Mary, and St. Joseph now and forever. It is certainly a very legitimate and important question to ask: “I wonder where is the right place to go to attend a valid Mass with a **jurisdictional** priest?” Because I do not know the name of the priest or bishop and physical address of such a place where both a valid and *licit* Catholic Mass is offered, I personally do not attend the services of non-Catholics.

The infallible Church founded by Jesus Christ certainly accepts the teachings of St. Thomas Aquinas on this matter. Namely, that no one receives grace when they receive the sacraments and/or attend the services of non-Catholics. In fact, Canon 1258 strictly forbids us to attend the services of non-Catholics. However, if you have read *My Petition for Spiritual Help* <https://jmjsite.com/f/my-petition-for-spiritual-help.pdf> and the *Combined Response* <https://jmjsite.com/f/cr.pdf>, then you already know these truths. You will also know that the CMRI sect and their clerics (and the sects and clerics of the rest of the Traditionalist Movement) do not have all Four Marks of the infallible Church.

You wrote that you have gone from Novus Ordo to CMRI. Am I correct in assuming that you changed because you realized that the Novus Ordo sect is a non-Catholic religion? It would be nice if you would respond and answer at least this one question: “When you came to the CMRI clerics did they have you make an Adjuration of Error and Profession of Faith for belonging to the Novus Ordo sect, before you were permitted to receive sacraments at their church?”

Now consider these points:

- 1) If the Novus Ordo is a non-Catholic sect, then you were a member of a non-Catholic sect.
- 2) If you were a member of a non-Catholic sect, then the infallible Church **REQUIRES** you to be received into the Catholic Church in the external forum by means of the Adjuration of Error and Profession of Faith before She permits you to receive sacraments in the Catholic Church.
- 3) If the CMRI clerics did not have you make the Adjuration of Error and Profession of Faith, then it would follow logically that they do not believe and/or follow the teachings of the Catholic Church. Or else they believe the Novus Ordo sect is the Catholic Church!
- 4) If the Novus Ordo sect is the Catholic Church, then there is no reason for the Traditionalist Movement to exist!
- 5) If the CMRI clerics did **require** YOU to make the Adjuration of Error and Profession of Faith before you can be considered a Catholic; then it follows logically that Bishop Thuc and Archbishop Marcel Lefebvre were also **required** to make the Adjuration of Error and Profession of Faith before they could be considered a Catholic – since they also belonged to the same Novus Ordo sect.
- 6) As far as I know, not one person in the entire world has ever provided the least amount of evidence that Bishop Thuc or Archbishop Marcel Lefebvre ever made the Adjuration of Error and Profession of Faith – thereby being received back into the Catholic Church –

after being full-fledged members of the non-Catholic Novus Ordo sect. If such an Adjuration of Error and Profession of Faith was made by Bishop Thuc or Archbishop Marcel Lefebvre; then please provide the name and information as to what Catholic cleric administered the Adjuration of Error and Profession of Faith (and who were the two witnesses), and did that Bishop or priest have the necessary jurisdiction and faculties to receive Bishop Thuc or Archbishop Marcel Lefebvre back into the Catholic Church?

- 7) It follows with correct logic that the entire Bishop Thuc and Archbishop Marcel Lefebvre lines of succession were started and remain a non-Catholic sect. All of the Bishop Thuc and Archbishop Marcel Lefebvre lines of succession stem from non-Catholic bishops who belonged to a non-Catholic religion. Consequently, they do not carry on the life, authority, mission, jurisdiction, or apostolicity of the Catholic Church any more than the Old Catholics or any other Protestant sect. Without getting into the arguments about the validity of the Bishop Thuc or Archbishop Marcel Lefebvre lines of consecrations, even if they actually do have valid orders, they have never had jurisdiction, and consequently, why does the Church supply jurisdiction to non-Catholics who received their Powers of Orders outside of the Catholic Church?

In conclusion, when asked where the Church is, it is also important to recall some known truths and know where the Catholic Church is not. Known truths provide much evidence that the Catholic Church is not found in the Novus Ordo or Traditionalist Movement sects.
