The U.S. government has just passed a new law called "The Affordable Boat Act," declaring that every citizen must purchase a new boat by April 2014. These "affordable" boats will cost \$54,000-\$155,000 each. This does not include taxes, trailers, towing fees, licensing and registration fees, fuel, docking and storage fees, maintenance or repair costs.
